Dates: *April 25 or 26 or May 18 or 19, 2019 *four classes **pick One**

Times: 0900 - 1800 ★ must attend all hours, non-negotiable

Description: **Must be Agency / Department sponsored.** This class will give you the basic crewmember knowledge to assist qualified Boat Operators of Boat 33 and 34. Skills will include lake orientation, boat orientation, basic static water rescues, hand signals, medical skills and boat based firefighting. Class will be limited to 10 students per day.

Fee: No fee for approved CAL FIRE / SLO County personnel only **with your Station's Captain signature / approval** on registration

Requirement: All Students **must be On-Duty** during all instructional hours of Training. OT approval through Supervisor.

*****Pre-requisite -** Login to **Target Solutions. Self-assign the Boat 33 Operations Crewmember** Pre-course work (#1). When you finish reading the PDF files you will be assigned a **written test**. You must pass with 100% to take this class. You can take the test as many times as necessary. The "**California Boating and Waterways boater's safety**" course (#2) **is also a required prior** to class course. The book with test can be picked up at Station 30 or Station 33. Test once completed will need to be mailed to the state.

What to Wear: Department uniform (pants, button up shirt, boots)

Bring: Bring items to be prepared for a day on the water (swimsuit, sunscreen, towel, water shoes, lunch, water, sunglasses, etc.)
