**Class Title:** SWIFTWATER RESCUE OPERATIONS (SFT RIVER & FLOOD WATER RESCUE)

**Dates:** May 07, 08, 09, 2019

**Times:** 0800 - 1700      ★ **must attend all hours, non-negotiable**

**Description:** **Must be Agency / Department sponsored.** This course will cover swift water safety, water dynamics, swiftwater rescue equipment and its use, strategy, and tactics for the swiftwater rescue, communications, medical considerations, and pre-planning. The course includes 20-hours of in-water drill time.

**Fee:** \$240.<sup>00</sup> Cashiers check made out to SLO COUNTY FIRE must be included in registration packet. Course enrollment and Fee Exemption for CAL FIRE SLU Personnel, PCF and Reserves with Station Captain signature / approval on registration.

**Awarded:** State Fire Training River and Flood Water Rescue (16-hour) SFM FSTEP certificate and CAL FIRE Swiftwater Rescue Operations (24-hour) certificate

**Requirement:** All Students **Must Be On-Duty** during instructional hours of Training

**What to Wear:** Students must wear their department's duty uniform (pants, button up shirt, boots).

**Bring:** Lifejacket (Type III or V), wetsuit (4/3 recommended) or drysuit, water helmet, water gloves, fins, booties or water shoes, sunscreen, water, lunch each day, towel, jacket, and extra warm clothes.

**Lodging:** Group campsites at the Kern River Campground near Bakersfield City FD Rio Bravo FS.
