Class Title: Surf Rescue Operations

Dates: **October 26 - 30, 2020**

Times: 0900 - 1700 ★ must attend all hours, non-negotiable

Description: Must be Agency / Department sponsored. Surf Rescue Operations is a 40-hour introductory course designed to provide the student with the confidence and skills necessary to work in a surf and ocean environment. Basic skills involving equipment, resources, and procedures will be taught to effectively perform a basic surf rescue. Meets NFPA 1670 and 1006.

Student must complete the Surf Rescue Operations Skill Sheet with 100% accuracy and a written test with 80% accuracy

Pre-requisites: Prior to taking the class students must pass a swim test of 500 meters within 12 minutes. Swim begins day 1 at 0900 at the base of Avila Pier: 444 Front Street, Avila Beach
Classroom portion will begin by 1000-1300 in the Coastal Gate Way Center at Port San Luis: 3950 Avila Beach Dr., San Luis Obispo, CA 93405

Fee: \$320 Cashier's Check or Money Order payable to **SLO COUNTY FIRE / SRO**, make sure **student name** is in the memo section. Cashiers check must be valid through 10/09/2020 (not expired). Payment must be attached to registration.

Course enrollment and fee exemption for CAL FIRE SLU Permanent / LTs and SLO County PCFs with your Station Captain's authorization.
