Class Title: SLO County Volunteer Fire Fighter Academy

Dates: February 6, 2021 - March 7, 2021, Saturdays and Sundays

Times: 0800 to 1700 all days ★ must attend all hours

Description: Must be Agency / Department sponsored. This class includes lectures and manipulative practice skills. The course is designed to be an entry-level training experience for individuals joining or serving with a fire department as a volunteer. Topics include: general safety, basic fire chemistry/behavior, breathing apparatus, portable fire extinguishers, forcible entry, rescue, ladders, water supply, hose loads, fire streams, communications, salvage operations, ventilation techniques, and wildland fire safety. This course is sponsored by SLO County Fire Training Officers, and SLO County Fire Department.

Prerequisites:

1. Students must be an official member of the Fire Department that is sponsoring them.
2. Students must be medically cleared and fit tested prior to registration.
3. Registration must be accompanied by a letter from sponsoring department stating the above, that you have passed the SCBA fit test and are medically cleared.

Students will receive pre-course work via email upon registration.

Fee: \$250 Cashier's Check or Money Order payable to **SLO COUNTY FIRE / PCFA**, make sure student name is in the memo section. USPS cashiers check preferred, must be at valid through 04/07/2021. Payment must be submitted with registration. Questions regarding registration fees, email SLU.training@fire.ca.gov. Registration is on first-come, first serve basis. Cancellations less than 10-days, no-shows or failures will forfeit fees. See registration box on pg. 2 for mailing address and additional information. It is your responsibility to confirm registration @ SLU.training@fire.ca.gov

SLU exempt registrations are emailed to SLU.training@fire.ca.gov. If you are paying for class - mail your registration with payment to SLU HQ (see registrations box pg. 2). All Students must be on duty during instructional hours of Training.

What to Wear: Students must wear their department's duty uniform (pants, button up shirt, boots) and approved Wildland Firefighting boots for practical exercise. No exceptions.

Bring: Wildland / Structure PPE, Department sponsored SCBA, notebook and #2 pencil. Bring your own lunch and water.
